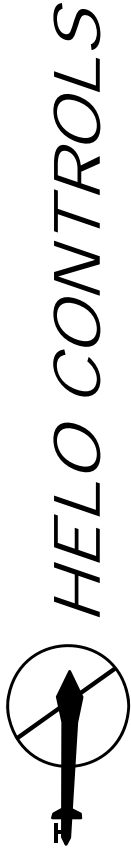

**Payment Terms**

All new accounts will be cash at time of order. After a probationary period, the dealer will be placed on an open account basis. Payment is due 14 days after the date of the invoice. After 30 days, the account will be considered past due and returned to a pre-paid cash basis. There will be a 1.5% Finance Charge (18% annual percentage rate) applied to the account balance should the account become delinquent. Accepted forms of payment are company check, money order, or thru PayPal. For PayPal payments, there is an additional 3% charge.

**Shipment and Freight**

Orders will be shipped via insured USPS Priority Mail for US Dealers and USPS Global Express Mail for International Dealers. Other shipping options may be requested. Actual shipping charges will be charged for all orders, including processing and handling. 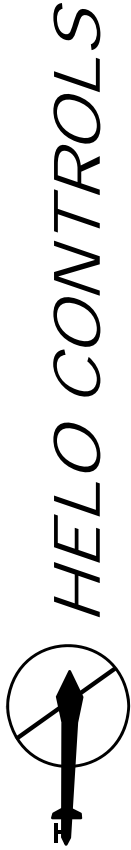
